

PRIVACY NOTICE

1. SCOPE OF THIS NOTICE

Please read this privacy notice ("Notice") carefully to understand our policies and practices regarding your Personal Data and how we will treat it.

This Notice applies to individuals who interact with [the app] ("Game" or "App"). This Notice explains how your Personal Data are collected, used, and disclosed by us. It also tells you how you can access and update your Personal Data and make certain choices about how your Personal Data are used.

2. PERSONAL DATA THAT WE COLLECT ABOUT YOU

We collect various types of information from you, as described below:

- (a) device identifiers (such as IDFA, IDFV);
- (b) behavioral usage of the App;
- (c) email address;
- (d) the type, version, brand, language and operating system of device;
- (e) the type and operator of network (such as Mac address).

3. PERSONAL DATA OF CHILDREN

We do not knowingly solicit or collect personal data from children below the age of 13. If we discover that we have unintentionally collected personal data from a child below 13, we will remove that child's personal data from our records promptly.

4. USES MADE OF YOUR PERSONAL DATA

The following paragraphs describe the various purposes for which We collect and use your Personal Data. We use your Personal Data for:

- (a) Maintain the safety, security, and integrity of our Services, for example fraud detection.
- (b) Understand how you interact with our Services and personalize the content (including advertising).
- (c) Market our Services (including any new features, as well as any existing, new or related products) to potential and existing users, including through in app messaging and push notifications.
- (d) Comply with legal requirements and/or to investigate or address claims or disputes relating to your use of the Services.

5. DISCLOSURE OF YOUR PERSONAL DATA

We share your Personal Data with the following types of third party organisations:

- (a) Service providers. These are external companies that We use to help Us run our business.
- (b) Third party recipients using Personal Data for legal reasons.

6. RETENTION OF YOUR PERSONAL DATA

We will use your Personal Data for as long as necessary to satisfy the purposes for which your Personal Data was collected, unless it is necessary to extend the retention period or as required or permitted in accordance with applicable laws.

7. SECURITY OF YOUR PERSONAL DATA

We use appropriate measures to keep your Personal Data confidential and secure. Please note, however, that these protections do not apply to information you choose to share in public areas such as third party social networks.

8. YOUR RIGHTS

- (a) Access, correct, and request deletion of your personal data.
- (b) Object to processing of your personal data, ask us to restrict said processing.
- (c) Erasure of your personal data.
- (d) Withdraw your consent. Withdrawing your consent will not affect the lawfulness of any processing we conducted prior to your withdrawal, nor will it affect processing of your personal data conducted in reliance on lawful processing grounds other than consent.

These rights can be exercised by contacting us. If the request is submitted by a person other than you, without providing evidence that the request is legitimately made on your behalf, the request will be rejected.
